I/We agree that I/we will have no right of action against Auswide Bank whatsoever should Auswide Bank refuse to stop payment on the abovementioned cheque.

 - To pay the payee/third party named above, the value of the abovementioned cheque if, in Auswide Bank's opinion, Auswide Bank, as drawer of the cheque was or is liable to honour the abovementioned cheque by making payment to the payee/third party named above (with Auswide Bank's opinion as to its liability being absolute and final).
- I/We will notify Auswide Bank in writing if we wish to withdraw or cancel this request.
- I/We understand and agree that Auswide Bank will not incur any liability whatsoever if the abovementioned cheque is honoured by its value being paid by the Westpac Banking Corporation to the payee/third party named above prior to Auswide Bank taking any action or making a decision concerning this request.
