When you choose Auswide Bank, you get more than just a home loan.

A Freedom Package, means you can apply to enjoy amazing benefits, including discounted home loan interest rates plus savings on loan and everyday banking fees, home & car insurance<sup>+</sup> and credit cards.

Auswide Bank Freedom Package benefits are available to new qualifying loan applicants.

A Package Fee applies. The Package Fee is currently \$395 per annum.

This Schedule of Package Benefits must be read with the Freedom Package Terms and Conditions (which can be found in the Auswide Bank Mortgage Booklet or on our website). This Schedule and the Freedom Package Terms and Conditions make up the terms and conditions of your Freedom Package. If you have not been provided with the Freedom Package Terms and Conditions, please ask us for a copy. To the extent of any inconsistency between these Terms and Conditions and the Schedule of Package Benefits, the Terms and Conditions prevail to the extent of the inconsistency. Warning: We can change the Freedom Package fees, benefits and terms and conditions at any time. Additionally, if you cease to meet the eligibility criteria for the Freedom Package (including if you fail to pay the Package Fee or no longer hold the required products) or if you are in default of any of your obligations to us under any product you have with us, your package can be cancelled and you will no longer receive the package benefits. We can also cancel your package on three months notice to you.

## SCHEDULE OF PACKAGE BENEFITS



### HOME LOANS & LINES OF CREDIT

#### Interest rate discounts!

- > As a Freedom package customer you will receive a discount off the applicable standard variable rate on your home loan or line of credit of \$100,000 or more.

Current Freedom Package discounts for new customers are available from our branches or our website. The discount applicable to an existing Freedom Package Home Loan is detailed on your loan contract.

#### Waiver of Loan Establishment Fee!

- > The standard Loan Establishment Fee is waived for each new or additional loan included in a new or existing Freedom Package. This waiver includes a Valuation Fee waiver of up to \$300 in total for new loans or \$300 in total for new/additional loans or top ups added to an existing Freedom Package - regardless of the number of loans in the Freedom Package or number of properties used as security.

#### Waiver of Account Service Fee!

- > The standard monthly account service fee is waived for new loans or additional loans taken under an existing Freedom Package.



### **Waiver of Principal Increase Fee!**

- > The Principal Increase Fee is waived when you request us to increase the principal amount of your loan under an existing Freedom Package.

### **Waiver of Complex Variation Fee when you switch to a variable or fixed rate!**

- > The Complex Variation Fee is waived when you switch from a Variable to a Fixed Interest Rate, or vice versa, during the term of your loan and while you have the Freedom Package. Complex Variation Fee may apply in other circumstances. Please be aware that break costs may apply.

### Save on bank fees!

> Open a Mortgage Offset\*, Everyday Access (or eligible Line of Credit Access Account) for all your day-to-day banking and we'll waive the monthly Account Service Fee applicable to these accounts while you hold the Freedom Package.

Transaction fees on withdrawals via Auswide Bank EFTPOS, internet/mobile/phone banking, BPAY®, personal cheques, direct debits and periodical payments are also waived while you hold the Freedom Package.
